- 4. Additions or Deletions to the Agenda: Motioned by Newton Pierce and seconded by Burton Whitman to add 7a. Sale of Airport property to agenda. Motion carried 5-0.
- 5. Liquor License Approval: Blair Hill Inn. Was no discussion as the discussion was during the Public Hearing. Motion by Richard Peat and seconded by Burton Whitman to approve the new liquor license for the new owner Jennifer Whitlow. Motioned carried 5-0.

- 6. Liquor License Renewal: Moosehead Marine Museum. No discussion. Motion by Richard Peat and seconded by Ronald Sarol to approval the renewal of the license. Motioned carried 5-0.

- 8. Town Managers Report: Town Manager met with Unifirst and Public Works ordered uniforms. Should arrive in 4-5 weeks. Pants/blue: tops/gray with town logo and their name. Town Manager received notice of a rate increase in tipping fees with Juniper Ridge Up another 5.7%. Total of 10% since January. Pre-bid meeting with Haley Ward and roads. Cancelled rugs and Unifirst and bought new rugs. A Forum was held Monday April 4th on the Red Cross Beach. 14 people showed up. All went wells all positive. School Zone lights to be taken over by Carl Henderson and school. Was brought up about School Community Service projects for lower class grades to do. Mike mentioned to clean up the leaves in the tennis and basketball courts. Town Manager brought up the Code of Ethics Policy again. Said it was never really put in place. Had all selectmen sign the agreement.
- 9. Public Comment: John Contreni brought up the Public Fence next to Varney Insurance could be painted (suggestions for more community service). Margarita Contreni mentioned children could help plant flowers at park.
- 10. What is on your mind? Richard Peat wondering about Fire Works. The Fire Works will be on Saturday 7/2/22
