- 1. Opening of the Meeting & Declaration of Conflicts of Interest: The Chairman opened the meeting and asked the members of the Board of Selectmen to review the meeting agenda and declare any potential conflicts of interest which members may have with the items listed. NONE NOTED
- 2. Minutes of September 5, 2018: It was motioned by Josh Brown and seconded by Richard Peat to accept these minutes of September 5, 2018. Motion carried 4-0. Murray entered meeting after this agenda item was voted on.
