Report from CEO: Ron reported on the period from 5/18/23-7/4/23. Ron continues to work on assigning 911 addresses to new properties and updating existing properties using the State's Geo-

lynx Server. Ron also continues to check the status of permits that are soon to expire to verify their progress. Ron issued 40 vendor permits for the July 1-2 fair. Ron is learning a new database for the CEO report and will eventually be posting it to the website. David inquired about what was being built at the old McDonald site. Once completed, the rear of the building will be for storage and the front half will be a store front for lease. John noted that the Holy Family Church digital sign was operating and asked when the sign would be put into compliance. Ron said he spoke with Joe D'Angelo and they were in the process of getting the sign into compliance.

New Business: Vendor's Ordinance. Dale Goodwin approached Ron regarding the current fee schedule. The amount is high, and some vendors will not attend the fairs. Ron provided the Board with Vendor fee schedules from different towns for comparison. The Board will review same for their next meeting.

Items for Next Meeting: Possible revision of Town Vendor's Ordinance. Review of used car lot on Moosehead Lake Road.

What's on your mind: Maureen and Lurline passed. Noel said he has now received his third call from a speculator regarding the sale of his house for a short-term rental. Noel also stated that the house that is located two-doors down from him, that is a short-term rental, was used over the July 4th holiday. The partying went late into the night. The parking lot was full of cars and ATV trailers. This brought up the discussion of how many homes are now short-term rentals and the lack of supervision and the need for some type of regulation. John said all our Ordinances were passed at the Annual Town Meeting. John also attended the June 29th meeting at the Bartley Center hosted by LUPC. The meeting was about short-term rentals in the Unorganized Territories. The meeting was well attended by approximately 35-50 people. LUPC would like to get regulations put into place. For example, owners would have to provide information regarding the capacity of the house, how many people would be there, emergency phone numbers, etc. David asked John about his meeting in New Hampshire with the Northern Forest Center. John said the Center's Spruce Street project for workforce housing is still in the planning stages. The Hospital is no longer involved in this project, so they are now working with a 5.5-acre plot.
