- \* ALL BACKGROUND CHECKS PAID BY APPLICANT. GET SIGN OFF FORM FOR POLICE
- \* ALL ADVERTISING FEES FOR PUBLIC HEARING PAID BY APPLICANT
- \* SQUARE FOOTAGE ON TIER 4. ADD UP TO 7,000 SQFT FOR \$2,000
- \* LATE FEES WHEN LICENSE LAPS: 10% OF LICENSE TOTAL 1-30 DAYS LATE. 10% EVERY 30 DAYS
- \* SEPARATE APPLICATION FOR EACH LICENSE
- \* SIGN OFF FROM CEO, POLICE CHIEF, FIRE CHIEF, PLANNING BOARD
- \* SIGN OFF FROM WATER/SEWER DISTRICT IF USING THESE UTILITIES
- \* ALL LICENSES ARE ANNUAL
- \* NO MORE THAN 3 LICENSES PER APPLICANT
- \* NO MORE THAN 30,000 SQUARE FEET TOTAL FOR ALL LICENSES PER APPLICANT
- \* TOWN OF DEXTER: MFG ONLY. NO FEE YET. NOT SURE WHAT THEY ARE GOING TO DO. TOWN COUNCIL DOES NOT WANT MARIJUANA BUSINESSES

- \* TOWN OF MILO: MARIJUANA STORES: \$500 APPLICATION FEE, \$1,500 LICENSE. ONLY ALLOW 2 IN TOWN. MERIT BASED SYSTEM TO AWARD
- \* TOWN OF JACKMAN. MEDICAL USE ONLY, NO ADULT USE. NO ORDINANCE, GOES BY STATE REGULATIONS. THEY DO NOT COLLECT ANY FEES.
- \* TOWN OF DOVER-FOXCROFT. ALL MARIJUANA USE IS PROHIBITED
- \* TOWN OF MONSON: ALL MARIJUANA USE IS PROHIBITED
- \* TOWN OF GUILFORD: I COULD FIND NOTHING ON THEIR WEB SITE. I E-MAILED TWICE AND CALLED ONCE BUT HAVE NOT RECEIVED A RESPONSE.
- \* STATE BASES THEIR CULTIVATION FEES ON OUTDOOR OR INDOOR/OUTDOOR CULTIVATION. EXPLAINS THE DIFFERENCE IN FEES
