1. Pledge of Allegiance. NOTED
2. Opening of the Meeting & Declaration of Conflicts of Interest: The Chairperson will ask the members of the Select Board to review the meeting agenda and declare any potential conflicts of interest which members may have with the items listed. 3. Election of Chair and Vice- Chair. It was motioned by Newt Pierce and seconded by Richard Peat to nominate Geno Murray as Board Chair. Motion carried 4-0 with Murray abstaining. It was then motioned by Ron Searles and seconded by Richard Peat to nominate Newt Pierce as Vice Chair. Motion carried 4-0 with Pierce abstaining.
4. Minutes: The minutes from 6/2/21 were presented. It was motioned by Richard Peat and seconded by Newt Pierce to accept these minutes. Motion carried 3-0. Whitman and Searles not members when this meeting held.

5. Additions or Deletions to the Agenda: Addition possible land acquisition at airport for hanger. It was motioned

Looking at road bond for next round of paving which hopefully will include a savings for the next roads that have been prioritized, fireworks will be on barge in East Cove. Moose Island Construction has donated their barge for the fireworks and offered to donate additional fireworks that would double the length of the show. Moosehead Island Construction also looking to expand at airport. Board accepted by consensus.
